With the upcoming departure of our current CEO, Cliff Prior, the Global Steering Group for Impact Investment is seeking a new CEO. This comes at a hugely exciting time for the organisation as we relaunch as "GSG Impact".

GSG and impact investing have come a long way in the past decade. Today we are active in over 50 countries, working to achieve our vision - that impact becomes a core factor in every investment, business and government spending decision. Our new name, GSG Impact, is a reinforcement of that Vision.

GSG Impact is a UK based charity that has developed a global community of national partners who are convening key players across their ecosystem to build local impact partnerships. 50% of our global footprint is in Emerging and Developing Economies (EMDEs).

We were supported by the UK G7 Presidency in setting up the Impact Taskforce (ITF, www.impact-taskforce.org) and our global partnership includes other GSG Impact initiatives such as the Education Outcomes Fund (EOF, www.educationoutcomesfund.org) and the International Foundation for Valuing Impacts (IFVI, www.ifvi.org).

Together, we work to accelerate meaningful impact transparency and a transformative shift of resources to deliver positive impact on the SDGs and climate goals.

This unique, symbiotic partnership allows us to connect global to local and generate multidimensional value from the flow of information and ideas across borders and sectors. We generate differentiated policy insight, develop know-how across the world and build coalitions of the ambitious in support of our calls to action.
